Decontamination and Sterilization

A Manufacturer's Recommendation

With some reusable medical devices (RMDs) being more "challenging" to decontaminate than others, any mistake has direct implications towards the safety of the dental team and patients. It is especially confusing when not all sterilizers/sterilization cycles are designed to sterilize every type of RMD.
